MAINLAND RESOURCES, INC. ANNOUNCES FORWARD STOCK SPLIT EFFECTIVE AS OF MAY 29, 2008

Houston, Texas / PR Newswire – May 29, 2008 –Mainland Resources, Inc., a Nevada corporation (the “Company”) (SYMBOL MNLU-OTCBB, 5MN-Frankfurt) has effected a forward stock split of the Company’s common shares as of May 29, 2008.

The forward stock split provides for the issuance of new shares at a ratio of 1.5 shares to 1 share for every share of the Company’s stock issued and outstanding prior to the dividend date. This action will take place automatically and the resultant share dividend will be mailed directly to shareholders without any further action on their part.

The forward dividend of stock will result in the total issued and outstanding shares in the Company to rise from 26,410,000 to 39,615,000 shares as of May 29, 2008.
